NOTIFICATION REGARDING THE MASTER DEGREE 4TH SEMESTER
DISSERTATION VIVA AND PLAGIARISM CHECK

It's to be considered as the Final Notice for Dissertation Viva, which supersedes all such previous Notifications.

1. The Compiled list along with the all the updated additional lists are to be taken as the final lists for dissertation Viva, which are published on the website. Those learners included in the Accepted lists are allowed to appear in the viva provided they have paid the fee and received the signature of the supervisor on the dissertation
2. Dissertation fee payment is compulsory for all. All have to take their fee payment receipt at the time of Viva. Signature of the Dissertation guide is also compulsory and without it, the learner will not be allowed, except for those learners whose names are on the updated additional lists published on 21/12/2024.
3. The learners included in the **Review list** will be allowed to appear in the Viva provisionally, if their reviewed reports have not been re-evaluated yet. They have to sign an undertaking that if their dissertation (reviewed) is not accepted later on, their Viva will be cancelled. Undertaking copy has been sent to the exam centre and also available on the website. They have to submit their reviewed copy of the dissertations to plagiarismcheck@kksou.in on or before **27th December, 2024**.
4. All those learners who have submitted their dissertations **to wrong email id or submitted after the last date (9th October, 2024)**, will have to wait for the **next Notification in the end of January or early February 2025. Special provision for them may be provided.** They have to pay the fee and keep the receipt with them.
5. The learners, whose names and enrollment numbers are in the **Rejected list**, they too have to **wait till the end of January or early February 2025. Special provision for them may be provided.** They have to pay the fee and keep the receipt with them.
6. If any learners name and enrollment number is in more than one list (due to technical reasons) then the learner will be given the benefit of the better list.
7. Those learners whose names and enrollment numbers are not found in any of these lists, **they have to wait till the end of January 2025.** As all emails sent to the plagiarism check on 19th and 20th December 2024 have been resolved, hence no more such applications will be entertained now. **However, if any coordinator firmly believes that the dissertation of any learner was submitted on time, but not included in any list, then the coordinator may allow him/her with undertaking in the Viva and then contact the University.**
8. If any discrepancies are found in these lists regarding the enrollment number/name/discipline, then the examiner will take a note of it and allow the learner to appear in the Viva.
9. MAJMC learners who have prepared audio-visual dissertations are allowed in the Viva without plagiarism check.
10. **Every stakeholders cooperation is anticipated.**
11. **Wish all the best to all the learners.**
